# 1. Introduction

Our website, <u>https://unicollaboration.org</u> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). # 2. What are cookies?

A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. In order to do this, various data about you is stored using web beacons.

# 5. Cookies

#### 5.1 Technical or functional cookies
