# **Proof of Consent**

This document was generated to show efforts made to comply with privacy legislation. #### 1. Introduction

Our website, <a href="https://www.unicollaboration.org">https://www.unicollaboration.org</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). #### 2. What are cookies?

## 3. What are scripts?

#### 5.1 Technical or functional cookies


