# **Proof of Consent**

This document was generated to show efforts made to comply with privacy legislation. ### 1. Introduction

Our website, <a href="https://www.unicollaboration.org">https://www.unicollaboration.org</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). #### 2. What are cookies?

## 3. What are scripts?

A script is a piece of program code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

## 4. What is a web beacon?

A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. In order to do this, various data about you is stored using web beacons.

## 5. Cookies

#### 5.1 Technical or functional cookies
